Rock Solid Athletics has worked to be and remain licensed by Texas Health and Human Services since its creation in 2011. Some of these are required under their rules and guidelines.

_____ I understand that I will be notified of any change in RSA Operational Polices.

_____ All contact information is up-to-date on my profile. It is important that phone numbers are kept current and that we are able to reach someone should we have to call.

_____ I will pack a lunch and drink for my camper each day. Pack plenty, we play hard. We have water refill stations and will encourage hydration. Fridays only, we provide Cheese Pizza.

_____ I understand that RSA will offer my camper a snack and drinks twice a day.

_____ My camper does not need help with self care. RSA Staff will not be helping campers in the restroom.

_____ I will label ALL belongings and check lost and found weekly. Label everything and help us encourage your camper to keep their things together.

_____ I will not allow my camper to bring toys or \$\$ to camp. This is a not a place for electronics or cell phones. Campers will be asked to keep anything extra in their bag.

_____ I will send my camper pre-sun-screened. We will also offer sunscreen for faces & shoulders before playing outside, however, we will NOT be able to assist.

_____ My camper will wear easy off/on shoes that are good for play and getting wet. Socks just get lost and slow us down! We are bare-feet in the gym.

_____ My camper will have a COMPLETE CHANGE of clothes/underwear in their bag. We get wet pretty much everyday. Most come in their swimsuit. We will not be able to help with changing.

_____ I understand that camp hours are 7:30-6p. You must park in a parking space (not the drive thru and come inside to check your camper in if curbside is not open.) You may pick-up your camper at anytime. Campers are allowed to return if needed after practices or appointments.

Curbside Drop-OFF 7:45-8:45am. ID bands are required to be on.

Curbside Pick-UP 4:45-5:45pm. Cards or QR codes are required.

_____ My camper will wear their "ID" bands while at RSA. (Available after 5/13)
Replacements are \$2 for each additional set.

_____ I give consent for my camper(s) to participate in water activities (splash pad, water slide).

_____ I will keep my campers info up-to-date regarding any changes in physical or medical needs, medications, allergies etc.

_____ I have read and agree to the policies and guidelines for childcare at Rock Solid in the handbook found at <https://www.rsa-gym.com/camps>.

_____ I have read and understand Rock Solid's discipline and guidance policies (in the handbook referenced above). Please take note of the 3-strike policy.
